


## **Roloids Extra Strength Softchews, Roloids Extra Strength plus Gas Softchews, Roloids Multi-Symptom plus Anti-Gas Softchews: Recall - Foreign Materials in Products**

U.S. Food & Drug Administration

**AUDIENCE:** Consumer

**ISSUE:** McNeil Consumer Healthcare, Division of McNEIL-PPC, Inc. recalled all lots of Roloids Extra Strength Softchews, Roloids Extra Strength plus Gas Softchews, and Roloids Multi-Symptom plus Anti-Gas Softchews distributed in the United States, following consumer reports of foreign materials in the product, including metal and wood particles.

**BACKGROUND:** The company's investigation determined that the materials were potentially introduced into the product during the manufacturing process at a third party manufacturer. While the investigation is ongoing, production of these products has been suspended and will not restart until corrective actions have been implemented.

**RECOMMENDATION:** Consumers who purchased product included in this recall should contact McNeil Consumer Healthcare, either at <http://www.roloids.com> [1]
